## Superintendent's Report:

Superintendent McCurtis welcomed everyone back and wished everyone a Happy New Year. He stated that he hoped they had a restful Christmas break. He added that he along with Kim McManaman and Board Member Kaye Breyer had attended a meeting of the State Dept. of Education regarding the status in growth of API and AYP scores. The state will send two members of the State Dept. and two members of the State Board of Education and along with district staff will work together to implement a plan. It will be reviewed again in July. He added that the district needs to produce improvement. He thanked Board Member Kaye Breyer for attending and stated that by a board member in attendance it carried a lot of clout with the State. He also added that the district has received approval to begin the 10 room project and should begin within the next two months. The district will also begin moving forward on the Central Kitchen.

## 1. Attendance

Supt. McCurtis stated that the monthly total was 3224 students enrolled for the month. Last month there were 3258 and one year ago there were 3184 students. We have improved in attendance and it's good to see progress.

Student Board member Jose Jaime reported that on Dec. 17<sup>th</sup> the Music Dept. held their Holiday Concert at MHS. Mr. Brady the music director coordinated this event and with his dedication to McFarland and its music dept the winter concert was a success. The concert was a great hit as well as the drumline. He added that finals were taken on Thursday, Dec 17<sup>th</sup> and Friday Dec. 18th . The Groundbreaking Ceremony was held on Thursday, Dec. 17<sup>th</sup>. Students were dismissed on Friday, Dec. 18<sup>th</sup> for Winter Break. Classes resumed on Monday, Jan. 11<sup>th</sup> and are off to a great start. They are looking forward to a good second semester.
